This High Speed Internet offer provides up to 75 Mbps download and up to 10 Mbps upload speeds with value-added features that include: 7 email addresses, Norton Security Suite, XFINITY TV Online and ESPN3.com.

- The equipment to be provided is two High Definition Digital Receivers.
- The term of the contract is for seven years with two years of auto renewals.

- There is an Annual Escalator of 4%
- Beginning rate is \$76.95 per home.
- There is a verbal agreement with the Comcast representative upon approval by Comcast management that the rate would not take effect until January 1, 2018.

The motion was seconded by Diana and passed unanimously.

The Board discussed the various PBG City Code violations occurring in the community. The most serious violations are brown or dead lawns of many homes, inoperable or broken irrigation systems, boat storage and visible trash receptacles in front of homes.
