New Business:

<u>Car Covers</u>- Board discussed the issue of car covers and decided covers would be allowed as long as license plate and parking sticker was visible.

<u>Fencing around Sheds</u>- 3 bids were reviewed, approximate cost \$4100. A decision will be made at next meeting.

<u>Complaint Policy</u>- Jeff Gorfido discussed how complaints would be handled by the office. All complaints must be in writing and submitted to the property manager for verification.

Gate Access- All 4 digit codes have been removed from the gate system.

<u>Plantings at the Entrances</u>- Board approved removing old plantings from the signs and replanting after the signs are painted. 5 additional plants will be put in at the Savoy gate.

David Rodgers spoke about the need to add color to the landscaping and suggested planting up to 12 "groves" of plants around the development. Approximate cost would be \$1200 - \$1500. Discussion about how this would affect the irrigation. More research would need to be done and project is on hold until current planting project is finished

<u>Background Checks</u>- Due to the fact that we no longer had access to run credit checks, the Board decided to continue running criminal background checks on all new residents.

Concrete Pads for Recycle Bins- 3 bids were received on installation of 13 pads, cost would be approximately \$8000. Project was shelved.
