Owners were present at the meeting to discuss their concerns with the Amendments that were mailed out. Areas of concern were the guest restrictions, dog weigh limits, flags, sale procedure timeline, etc. The Board listened to the owner's suggestions and will make alterations to them. The Board has asked owners to stop voting and wait for the revised amendment.
