Roy Sangster attended the meeting to discuss the lake restoration project. The engineers will work with SFWMD and Lake Worth Drainage District to make sure that the restoration of the lake and the littorals are brought back to their requirements. Management will work with the engineering firm to map out the problem areas and provide a progression report of land loss. The estimated cost could be around \$275,000. Dividing the cost will be easier to budget but may be a greater cost over time.

The Board reviewed the minutes from the June 13, 2018 Board of Directors Meetings. MOTION: Dave Brant made a motion seconded by john Kavanaugh to approve the minutes from the June 13, 2018 Board of Directors Meetings. The motion carried 5-0.

When the samples come in the Board will review the colors.

The Board discussed the landscaping issues. Management will work with the landscaper to get the property back on track.

The Board discussed the lights in the community and agreed to move forward converting the lights to LED at this time and hold off on changing and adding new poles.

Management gave an updated on the pool. Currently the project is in for the permit applications.
