Entry Improvements: The entry paver project has now been completed and the new pavers have been sealed. Re-sealing will occur on an appropriate schedule to maintain the integrity of the pavers. A new exit gate arm system was also installed. The new exit gate arm only raises when you slowly ease close to the arm. If you approach the gate arm at an excessive rate of speed the arm will not raise in time for you to pass through. The entry arm will still raise when the guards activate the guest side arm and your resident sticker activates the resident side arm. As always, proceed with caution when changing lanes after the entry arms.

Gate Arm Damages: If you knock off any of the gate arms you will be assessed a service fee of \$100.00 <u>PLUS</u> any other charges that may be incurred to restore the gate and arm to perfect functioning form.



The Community speed limit is 15 MPH. Please report any vehicle expected of speeding to the guards. Include a license plate number and location of the event and the guards will attempt to contact the vehicle driver.

Hurricane Dorian: No significant damage occurred to POA property. Thank you to everyone who helped secure the golf cart and secure the tennis nets/screens. Thank you to Captain Jennifer and all our guards for securing the community, preparing our residents and reopening the community expeditiously. Tennis Courts: We are in the process of selecting new benches, covers and fountains for the tennis courts. It's our intension to start this work in the coming months. Until the end of the current hurricane season, wind screens will remain up around courts one and four. As always, <u>NO</u> pets are allowed on the tennis courts. Please report any pets on the tennis courts to the guards. Include a picture of the dog and the time of the event to the guards. Legal letters and possible fines will follow.
